

School Parent and Family Engagement Policy D'Iberville Elementary School 2021-2022

In support of strengthening student academic achievement, **D'Iberville Elementary School** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy, agreed on by such parents, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. A. ANNUAL TITLE I MEETING

D'Iberville Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parental involvement policy, the schoolwide plan, and the school-parent compact.

D'Iberville Elementary School will hold the Annual Title I meeting in August. The meeting will be recorded and placed in the Federal Programs folder in Schoology for all parents to view.

D'Iberville Elementary School will provide parents of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging state academic standards, and
- d) if requested by parents, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable.

Information related to the school and parent programs, meetings, and other activities, will be sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand

D'Iberville Elementary will distribute the School-Parent Family Engagement at the Annual Title I Meeting. All students that enroll after this time will receive the information during registration. D'Iberville Elementary School will hold monthly meetings to provide information related to school and parent programs. Information will be provided in a format, to the extent practicable, and in a language that parents can understand.
